Children will need to bring a home lunch as lunch will not be served at Jolley School for the month of May and August. Children will eat their lunch in the St. Agnes gym on those days. Please do not bring items that need to be warmed up. If any items need to be refrigerated, please provide your child with an ice pack in their lunch box. Water will be served with those meals. If you would like your child to have milk, you will need to provide that for them.

Your student will have a summer program shirt we will keep on site for off-site events. You will be able to take your shirt home as a souvenir at the end of the program! Please also have children wear weather appropriate bottoms that are breathable and comfortable as well as appropriate footwear for walking and outdoor play no flip flops for preschool age students. The summer permission form will be sent home during registration and the first days of the program. Please fill this out and return it ASAP and return by Friday May 31st, 2019. If a child does not have a permission slip, they will be unable to attend the offsite event for that day.

All students in preschool through 5th grade need to purchase a summer bus pass for \$75.00 from the Vermillion Public Transit office located on High Street across from the 4H offices. This pass will cover ALL travel in town and out of town. This will ensure that all children are safely transported to and from events.

Pool Policy/Permission Slip

Policy

- All City of Vermillion Swimming Pool rules will be followed
- The lifeguard on duty will determine swimming ability
- All children will arrive at the pool with Red and Gold staff and will not be allowed to leave the pool without written parental consent
- Parents who drop off their children at the pool may not leave until they have notified a Red and Gold staff employee of their child’s arrival and should verify that their child’s name has been added to the attendance list
- Any child that does not obey the instructions of the Red and Gold staff or lifeguard will not be allowed to swim for the rest of the day
- A signed permission slip must be on file for a child to be taken to the swimming pool.
- No child will be allowed to jump off a diving board or go down the slide without the permission to dive and/or slide section signed by their parent or guardian.
